US DIOCESE Executive Council's Resolution

The Executive Council of USA Diocese met again today March 13, 2021 to deliberate and take a stand on the current letter of amusement circulating within the system from the destabilizing committee. Thirty Eight members were in attendance and the following twelve resolutions were unanimously approved:

1. The Diocese shall maintain its allegiance to the seat of the Pastor and Spiritual Head of the Church and the Board of Trustees.
2. The USA Diocese remains resolved, irrevocably to maintain its solid and unfettered stand, status and avowed position as already reiterated in the Diocese's Memoranda #05 – 21 of March 11, 2021.

4. The Diocese shall continue to pursue both its short and long term agenda and programs without entertaining any encumbrance.

6. The destabilizing committee spurious letter has no legal standing and shall not be read in any USA Diocese Parish, so as not to create confusion for the congregation.
7. The Diocese is aware of deceitful and seditious calls emanating from the destabilizing committee to put shepherds, officers and members of parishes under pressure to join their cause. Shepherds are to watch out for this subterranean move. They should be boldly rebuffed and repudiated.
8. Since AVSE Solomon Yusuf has not refuted his membership of the destabilizing committee, he is hereby excused from the membership of the Council.


