### USA DIOCESE COMMUNIQUE

January 3, 2022

**National Executive Council Meeting held on January 02, 2022**

**Attendance: 31 (Including all Regional Supervisors, all States Supervisors except the replaced 3, all National directors, all Regional Women Council Chairpersons and Directorate of Youth Rep.)**

At the meeting of the National Executive Council representing 46 community based and administratively strong Parishes spread across the seven regions of the country, the current developments and issues going on around our Diocese and the Church at large were discussed, reviewed, and critically analyzed. The following observations and Resolutions were taken:

- ❖ The Diocese shall proceed without any inhibition, digression, or distraction with all its immediate, short term and long-term activities and developmental programs under the Executive Council and its Head of Diocese VSE Joseph Olorunnisola.
- ❖ The Diocese shall maintain its structure and continue to engineer improvement, enlargement, and enrichment in its administrative mechanism to make it more dynamic and responsive to contemporary challenges.
- ❖ The Diocese shall be willing and ready to expand its regional, states and directorates to accommodate legitimate rights and claims.
- ❖ The Diocese shall take immediate steps to fill the three vacant States supervisory positions,

- ❖ All the Systems, parishes and properties of the Diocese shall remain protected and secured.
- ❖ The Secretariat of the Diocese shall release the 2022 Harvest Schedule for the year.
- ❖ The Council is profoundly grateful to all the Shepherds for their strong stand and focus.
