Dear Fellow Celestians,

**RE: Summary and Resolution from the USA Diocese Meeting with the Pastor at New York Parish, New York – Thursday September 29, 2022**

At the request of the Pastor, Reverend E.M.F. Oshoffa, VSE J.O Olorunnisola and select members of the US Diocese Exco, met with his eminence in New York, New York Parish, on Thursday, September 29<sup>th</sup>, 2022, the 75<sup>th</sup> anniversary of Celestial Church of Christ, to discuss the current state of affairs of the church within the United States of America. VSE Balogun and his group were also present at the meeting to present their side of the narrative.

The following are the highlights, summary, and resolutions from the meeting:

1. Upon the apology and hearing the detailed presentation from VSE J.O. Olorunnisola and his team of Elders, the Pastor declared all misunderstanding and misgivings between him and VSE J.O. Olorunnisola completely over, and their relationship fully reconciled.
2. The Pastor requested that VSE J.O. Olorunnisola maintain active, open communication and dialogue with him henceforth, as was the history of their relationship.
3. The Pastor did not at any time in the meeting say or go against the current status of the Diocese, with 42 parishes and members under VSE J.O. Olorunnisola's administration as HOD of U.S. Diocese continuing to work as they are currently doing, while those under the other group likewise continuing to maintain their status quo.
4. The Pastor indicated that when he returns to Nigeria and deliberates further with the elders; thereafter, he would decide on a final resolution, which will be communicated.
5. Furthermore, the Pastor's Head of Admin, AVSE Adeniyi, confirmed that five (5) out of the recommended seven (7) proposals initially presented by the US Diocese under VSE J.O. Olorunnisola have already been assigned to a Special Committee for implementation.
6. Based on the aforementioned outcomes, the forty-two (42) parishes under VSE J.O. Olorunnisola's leadership will continue their allegiance to the office of the Pastor in the spirit of this divinely inspired reconciliation, for the peace and prosperity of Celestial Church of Christ, and the hope and expectation of a divinely inspired resolution that will consider the irrefutable facts and proposal of the US. Diocese presented to the Pastor during the meeting.

Finally, let it be unequivocally clear, that these are the facts of the meeting as it occurred. Any spurious circulation purporting the contrary, is simply an unfortunate attempt to reverse the progress achieved during the meeting, and to serve an agenda that is contrary to the spirit and mission of the amicable meeting held with the Pastor.

On this 75<sup>th</sup> anniversary of Celestial Church of Christ, Ijo Mimo ti Kristi lati Orun wa, we greet every Celestian in the Name of the LORD, and we pray that the grace and unimpeachable word

of our LORD and Savior, Jesus Christ, see this Last Ship of Salvation into its glorious destination.
