### Memorandum #08 - 2021

### US Diocese Executive Council Resolutions (SCR – 2/03) of March 21, 2021

Brethren in the Lord,

At the Special Executive Council meeting of US Diocese held today March 21, 2021 the following resolutions were unanimously taken:

1. The Council observed that the former grand patron had nothing to hand over after his earlier 25 years of service as Head of Diocese. No asset, no account, no structure and no administration were handed over.
2. The Council shall take every available steps and measures to protect all the assets and obligations entrusted to its integrity by the members of USA Diocese and other participating parishes. The Council will under no circumstance allow the monuments and structures built over the last ten years to be destroyed or desecrated.
3. The Council is satisfied with the continue loyalty, integrity, and commitment of all its Regional and States Supervisors, Regional Secretaries, Treasurers, various projects Chairmen and Directorates. Information will, therefore, continue to flow through the Regional secretaries and Pastoral funds through the Regional Treasurers.
4. The Council observed with disdain the subterranean campaign of calumny, threats, intimidation and oppression being mounted against shepherds, officers and members of the Diocese to breakthrough, scatter, mutilate and destroy the body of Christ under the guise of Pastoral order. The Council called for restrain and caution to stem this unethical propaganda designed to turn the houses of worship established with the blood of the Lamb to social and political arena. "There are many devices in the hearts of men; nevertheless, the Counsel of the Lord alone will stand."
5. Parishes through their Regional Secretaries shall submit their Harvest dates on or before April 15, 2021 to the Diocese's Secretariat for compilation, dissemination and publication on the Diocese website. The new Harvest Invitation and Program Brochure Template will be sent by the Chairman of the Corps of Compliance officers very soon.
6. The Property development committee shall proceed with Imeko Project in accordance with the directives spelt out by the Executive Council of the Diocese.
